6. Specify if logo shall be used on materials other than letterhead paper	
7. Specify whether university logo should be included in the logo block and, if so, please transmit high resolution version ( <b>eps file</b> ) to <a href="mailto:unitwin@unesco.org">unitwin@unesco.org</a>	
8. If university logo features separately, please specify where the UNESCO logo block will be positioned
